This document notifies you that:

1. The Glenmark Community Against Wind Turbines Incorporated will on Monday the 6th day of December 2011 at 10.00am apply to the Environment Court at Christchurch for an Order:
 - a. Waiving the requirement on Glenmark Community Against Wind Turbines Incorporated to have given notice under section 274 of the Act within time; and
 - b. Extending the time within which Glenmark Community Against Wind Turbines Incorporated must give notice under section 274 of the Act to 8 December 2011; or
 - c. In the alternative correcting the name on the s.274 Notice dated 14 August 2011 bearing the name *Hurunui Community Against Wind Turbines Incorporated*, to instead read *Glenmark Community Against Wind Turbines Incorporated*.

Upon the grounds:

1. Glenmark Community Against Wind Turbines Incorporated (the "Glenmark Society") made a written submission in opposition dated 23 May 2011.
2. That submission was signed by the chairman of the Glenmark Society Graeme Higginson.
3. On 14 August 2011 Graeme Higginson signed and lodged a s.274 notice, recording the name of the submitter as *Hurunui Community Against Wind Turbines Incorporated*.
4. There is no such incorporated society as *Hurunui Community Against Wind Turbines Incorporated*.
5. It was Mr. Higginson's intention as chairman of the Glenmark Society to lodge a s.274 notice on behalf of the Glenmark Society.

6. Attached to this application is a copy of the Certificate of Incorporation of the Glenmark Society.
7. The Glenmark Society had intended to lodge a s.274 notice within time, but by simple error has failed to do so by mis-stating the name of the Society on its notice.
8. No party will suffer any undue prejudice if such orders are granted.
9. As appears in the affidavit of Graeme Higginson dated 29 November 2011 sworn in support hereof.

This application is made in reliance on sections s.281 Resource Management Act 1991.
