Subject: Revised schedule of estimate of cross examination times.

Dear Holly.

Further to our recent communication regarding my cross examining some 274 witnesses, Natasha Garvan of Bell Gully emailed me the original schedule sent to the Court regarding cross examination times. This has now been revised with further input from the 274 and lay witnesses as well as my own alterations. The alterations also incorporate input from Belinda Meares who has also been communicating with you. See attached.

I make the following additional comments regarding this schedule.

1. A new column has been inserted to accommodate the individual 274 and lay witness cross examination.
2. All these parties have been circulated as regards giving advanced notice of their wish to cross question.
3. I point out that there may be some additional cross questioning requirement from these persons depending on whether they consider there remains some further cross questioning that they wish to do personally of any expert having listened to the cross questioning of any expert by others. Hence the TBC left in the column.
4. I have inserted my name under the list of experts covering the subjects landscape, recreation, traffic, valuation, and noise. As per the supplementary schedule that I submitted to you following Bell Gully's original submission to you.
5. Whilst acknowledging Judge Harland's Direction to me regarding noise, I have kept myself listed under the noise experts section for the reason that whilst I am not an expert on some aspects of noise I am an expert on the current noise levels on the Tipapa Property and at the Homestead and woolshed, and the impact that any alteration to the existing levels of noise will have on the the property having lived here since I moved in upon completion of renovations in January 2005. I will therefore be presenting as an expert to the Court on this area of my expertise.
6. I have left my name in under Tipapa Ltd's witnesses as others have written in times they wish to cross question me, and I am not sure how the timings are broken up between each section.
