I received the email below from John Carr.

John Carr did place a disc of his 'expert evidence' in my mail box last Monday, as you are aware this is an electronic copy and not a hard paper copy as directed by the court. The disc arrived over 3 weeks after the evidence was filed in court.

For your information the disc had 230MB of data on it comprising 465 pages in one file with no table of contents, with some pages orientated at 90 degrees, making reading and referencing extremely onerous.

It is somewhat ironical that John Carr wrote on his Form 33 dated 30 August 2011 that he wished to receive all communication by way of hard copy, yet here he is trying to renege on court directions of providing hard copy of his evidence to all submitters. It is also very ironical that John Carr has become very concerned about the environment when it comes to printing out his evidence given the amount of paper that he has distributed as notices, flyers etc to the local residents mailboxes since the project was announced.

Therefore, as earlier requested, I would appreciate it if you could arrange for John Carr to comply with the court directions to provide myself (and others?) with a hard copy of the Tipapa evidence as soon as possible.
