Hi Helga,

Waka Kotahi appreciates your patience while we discussed the recent modelling undertaking for the intersection of Amberley Beach Road and Carters Road (State Highway 1).

Waka Kotahi recognises that the new intersection to Carters Road was a condition of consent for the adjoining landowners under RC200045, and therefore anticipates that the intersection would be completed by that consent holder and that it is therefore unnecessary to require the intersection to be constructed by the current applicant.

Based on the recent modelling undertaken by Mr Wayne Gallot, our safety engineers (James Long and Jodi Enright) have advised that they are comfortable, from a safety perspective, with the proposed subdivision progressing without the intersection being constructed immediately. The modelling indicates that the level of service of the existing intersection with Amberley Beach Road and Carters Road (SH1) will not significantly change in the AM and PM as shown in Mr Gallot's evidence. The form of the controlled intersection, with the give-way from Amberley Beach Road to Carters Road and the right turning bays, is considered to be satisfactory for the anticipated vehicle movements from the development.

In the Representations in Reply on Behalf of the Applicant, it is noted that the applicant has suggested potential wording for conditions of consent for Stage 5 and 6. If the Commissioners considered a staging approach appropriate in this instance, Waka Kotahi would be supportive of this approach.

In terms of the acoustic bund, the comments provided on the 2nd June addressed the physical form of the acoustic barrier and associated landscaping. Additionally, Waka Kotahi is interested in the ability of the acoustic barrier to achieve the design noise level of 40 dB LAeq (24h) and it is considered that the proposed draft conditions will ensure this is achieved within those proposed dwellings established on the allotments adjacent to State Highway 1.

Hi Helga,

I have received an update from our Safety engineer. He has advised that Wayne Gallot is preparing some baseline count data to update the modelling for the Amberley Beach Road/Carters Road intersection. It would be appreciated if we could have an opportunity to review the modelling before drawing any conclusions on our comfort with the proposal.

In relation to the acoustic bund, Waka Kotahi supports the use of the bund and fence as it will help mitigate reverse sensitivity effects from highway noise on the proposed residential dwellings to be constructed close to the highway (within 1000m). We also note the addition of the bund to the site in this location will not affect sightlines for vehicles travelling on the highway. Also, for maintenance purposes once the bund is constructed we would expect the bund to be fully landscaped on the state highway side of the bund and that it is constructed to have a gradient between 4:1 and 3:1 (H:V). Further clarification would be appreciated on who's responsibility the maintenance of the bund on the state highway side would be following the five years after the s224 certification.
