## **DECISION (ON THE PAPERS)**

This is an application by Hanmer Springs Golf Club Incorporated for renewal of an Club Licence in respect of premises situated at 133 Argelins Road, Hanmer Springs, known as "Hanmer Springs Golf Club".

No changes to the conditions of the licence have been sought by the applicant.

The Hanmer Springs Golf Club holds a Class 2 club-licence which allows the club to hold longer trading hours, than most other clubs in the Hurunui District which hold Class 3 licences.

The licensed trading hours are:

### Sunday to Friday from 10.00am to 10.00pm and Saturday from 10.00am to 12.00 midnight

The Inspector discussed with the Club Manager that the bar can only be open in relation to club-related activities; i.e. not for events that should be held under special licences.

The licensed areas are undesignated and include:

### The interior of premises and adjacent paved veranda area

The application was duly advertised and no objection or notice of desire to be heard has been received.

The Police and the Licensing Inspector opposed the renewal of the Hanmer Springs Golf Club's club-licence. The issues raised related to the staffing, training and systems at the

club, which were considered to be inadequate to meet the requirements under the Sale and Supply of Alcohol Act 2012.

The Licensing Inspector has met several times with Garry Ritsma, the new club manager and conducted a training session at the club. Garry has been the Club Manager since March 2019. He has been instrumental in the development and implementation of systems and training at the club.

Committee members and club staff attended the training session held by the Licensing Inspector.

The Inspector considers all issues have been dealt with sufficiently, with systems reviewed and updated at the club.

The Police opposition was withdrawn by email on July 17 2019. The Inspector's opposition was withdrawn on July 17 2019.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 02 June 2022, that being the anniversary date of the licence and three years from the most recent date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.
