DECISION (ON THE PAPERS)

This is an application by Amberley Rugby Football Club for an club-licence in respect of premises situated at 6/50 Douglas Road, Amberley, known as “Amberley Rugby Football Club”.

The general nature of the business to be undertaken is that of a sports club with the hours authorised for the sale of alcohol being Monday to Friday 6.00pm to 11.30pm and Saturday 3.00pm to 10.00pm.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In discussions with the Inspector the applicant has agreed not to licence any outside areas and that conditions are placed on the licence with respect to a manager on the premises and a register of hours and activities.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol, to any person for consumption on the premises and to let people consume alcohol there.

The licence may issue immediately with the following conditions

- The licence can only operate when a certified manager is on duty on the premises.


- The licensee shall maintain a register of the hours the licence is operated including the relationship of operating hours with particular club activities; e.g. competition games, formal training sessions, formal meetings etc.

Requirements on holders of on-licences

The applicant's attention is drawn to ss. 51 to 54 of the Act where it is a requirement for all holders of a club-licence to ensure that:

- (1) at all times when the premises are open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.
- (2) at all times when the premises are open for the sale and supply of alcohol, a reasonable range of food is available for sale and consumption on the premises, in portions suitable for a single customer, at reasonable prices and within a reasonable time of being ordered.
- (3) ensure that, at any time customers are lawfully on the premises there is readily available free, comprehensive, and accurate information about the forms of transport from the premises that are available at that time.

"With an event this size and the large number of people who will be driving we think that not only it is a responsible and important expectation but that is also reasonable to expect the organisers of the event to provide a low-alcohol drink option".

Under section 142 the committee must have regard to the applicant's proposals relating to low alcohol drinks but unlike section 52 which relates to on-licences and club licences, there is nothing in the Act that says that the holder of a special licence must supply low-alcohol options.

The committee has considered the concerns of the police but as the event is primarily a wine festival where the stall holders do not produce low alcohol options, the committee feels the application meets the intention of the act.

Under the alcohol management plan submitted with the application the applicant has indicated that wrist bands will be issued to patrons entering the event who are 18 years or age or older and are not intoxicated.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.

The licence may be issued immediately with the following condition.

- Patrons 18 years or older must be wrist banded in order for them to purchase and consume alcohol on the premises.






