The applicant has held a manager's certificate since September 2012 and this was renewed for a three year term in September 2013.

Ms Arthur has indicated in her application the steps that she has taken to manage the sale and supply of alcohol, with the aim of contributing to the reduction of alcohol-related harm.

Ms Arthur states that she ensures that free water is accessible at all times, food options are displayed and available and that intoxicated people are identified and service is disallowed.

The applicant successfully completed the Licence Controller Qualification Bridging Test on 2 September 2016.

There have been no convictions recorded against the applicant since her last renewal.

Although the Police raised no matters in opposition to the renewal the District Licensing Inspector considered the application should be considered at a public hearing due to the lack of sufficient recent experience managing licensed premises.

In the Inspectors report it was indicated that the applicant only worked as a duty manager at the cellar door when the other duty managers were ill or otherwise not available. This appeared to be for no more than once or twice a month. After considering the application the Committee asked the applicant if she would consider an "undertaking" to only use her Manager's Certificate in her current relief position at Greystone Wines or at special events where Greystone Wines had a special licence.

The applicant has confirmed and accepted this undertaking therefore the Committee considers that the criteria set out in section 227 of the Act has been met and the application can be granted on the papers.

A new certificate and renewal notice can be issued and will remain in force until 19 September 2019-

Under section 112(2) the Committee must ensure that when it issues or renews an offlicence for premises that are a supermarket or grocery store, it imposes on the licence a condition describing one area within the premises as a permitted area for the display and promotion of alcohol.

In describing alcohol areas the committee must have regard to section 112(1)The purpose of this section is to limit (so far as is reasonable practicable) the exposure of shoppers in supermarkets and grocery stores to displays and promotions of alcohol, and advertisements for alcohol.

In their report the Medical Officer of Health had no opposition to the application subject to the changes to the single alcohol area, as proposed by the current licensee Carroll Holdings Limited, being implemented. The Police and District Licensing Inspector have raised no matters in opposition to this application although the Inspector has advised that a building certificate has yet to be issued.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol, to

any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.

The licence will be issued with the following condition on confirmation of the completion of the single alcohol area and obtaining a building certificate.
