This is an application by Tulls Supermarket Limited for an off-licence in respect of premises situated at 2 Rolleston Street, Cheviot, known as "Cheviot Four Square".

The general nature of the business to be undertaken is that of a Grocery Store with the hours authorised for the sale of alcohol between Monday to Sunday from 8.00am to 9.30pm.

The applicant is a new company that has not previously held an alcohol licence. The applicant has previously been operating under two consecutive Temporary Authorities. This was necessary due to delays in issuing the Code of Compliance for the shops automatic sliding doors which had been installed without a building consent by the previous licensee.

Under section 112(2) the Committee must ensure that when it issues or renews an off-licence for premises that are a supermarket or grocery store, it imposes on the licence a condition describing one area within the premises as a permitted area for the display and promotion of alcohol.

In describing alcohol areas the committee must have regard to section 112(1)-
The purpose of this section is to limit (so far as is reasonable practicable) the exposure of shoppers in supermarkets and grocery stores to displays and promotions of alcohol, and advertisements for alcohol.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.

The licence may issue immediately with the following condition:

- The only area delineated on the attached plan is a permitted area for the display and promotion of alcohol


