In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 15 February 2020, that being three years from the first anniversary of the licence.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.

DECISION (ON THE PAPERS)

This is an application by Hurunui Rugby Football Club for an on-licence in respect of premises situated at 36 School Road, Culverden, known as "Culverden Rugby Football Club".

The general nature of the business to be undertaken is that of a Sports Club with the hours authorised for the sale of alcohol being Tuesday – Friday 6.00pm to 9.00pm, Saturday 12 noon to 10.30pm and Sunday 12 noon to 8.00pm.

The application was duly advertised and no objection or notice of desire to be heard has been received.

The Act does not require clubs to have a certificate holding manager to be on duty at all times the bar is open. The Police, Medical Officer of Health and the Inspector consider that rugby clubs in the Hurunui District should only open their bar when a certificated duty manager is on duty on the premises. The Inspector requests that the Licensing Committee impose a condition on the licence requiring this.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol, to any person for consumption on the premises and to let people consume alcohol there.

The licence may issue immediately with the following conditions.

- The licence can only operate when a certified manager is on duty on the premises.

- The licensee shall maintain a register of the hours the licence is operated including the relationship of operating hours with particular club activities; e.g. competition games, formal training sessions, formal meetings etc.

Requirements on holders of on-licences

The applicant's attention is drawn to ss. 51 to 54 of the Act where it is a requirement for all holders of an on-licence to ensure that:

- (1) at all times when the premises are open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.
- (2) at all times when the premises are open for the sale and supply of alcohol, a reasonable range of food is available for sale and consumption on the premises, in portions suitable for a single customer, at reasonable prices and within a reasonable time of being ordered.
- (3) ensure that, at any time customers are lawfully on the premises there is readily available free, comprehensive, and accurate information about the forms of transport from the premises that are available at that time.

The issues addressed in the decision related to limiting the exposure of shoppers to displays and promotions of alcohol and advertisements of alcohol. There does not appear to be anything in the decision that would require any changes to the current single alcohol area at the Hanmer Four Square store. The advertising is limited to a 'chilled beer and wine' sign above the alcohol display in the single alcohol area and there is no end of aisle display of alcohol.

In their reports, the Police, Medical Officer of Health and District Licensing Inspector have raised no matters in opposition to this application, however the Medical Officer of Health made comment on the exposure of shoppers to alcohol:

'While the current SAA is not ideal relating to exposure to shoppers on entry to the premises, I accept that the applicant has chosen the best location available to reduce exposure and therefore believe it meets the 'as far as practicable' threshold. Once passed the initial limited exposure, there is no further exposure to shoppers, right through to the checkouts (general point of sale).'

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 09 June 2020, that being three years from the first anniversary of the licence.


