DECISION (ON THE PAPERS)

This is an application by Hanmer Hospitality Limited for renewal of an On-Licence in respect of premises situated at 47 Amuri Avenue, Hanmer Springs, known as "Monteiths Brewery Bar Hanmer".

The applicant also seeks a change to designation of the licensed area within O'Flynn's Bar which had previously been 'undesigned' to 'supervised'. This change had been discussed with the licensee prior to the renewal application being lodged and is considered appropriate for that part of the premises.

The hours sought on the licence application were not clear as to whether the applicant was seeking the outside courtyard area to be licensed until 2.00am. The applicant advised that an extension of the trading hours for the courtyard area was being sought however this was later withdrawn.

Since the application has been lodged, the Springs Deli Café area of the premises has been refurbished and re-named the Roasted Bean.

The application was duly advertised and the application was opposed by both Police and Medical Officer of Health on the following grounds:

Failed CPO 9 April 2016. The applicants' actions following the failed CPO were of concern as the licensee did not accept the suspension and sought a hearing, then requested the previous offer be accepted. Prior to the suspension, the applicant made critical comments regarding the processes of the Authority to the media. All of which brought into question their suitability.

Extension of Trading hours. The applicant did not provide any details regarding the operation of the extended hours in the courtyard area nor why it should be considered as part of the application. Extending the outside trading area could affect the good order and amenity of the location. Noise has been problematic at other licensed premises in Hanmer Springs particularly those with outdoor licensed areas.


The server who made the sale during the CPO had been trained four days prior to the offence. The Police suggested that the training systems needed to be reviewed.

After a full and frank meeting with the licensees, the Police and the Medical Officer of Health agreed to withdraw their opposition as long as a full training document was produced showing up to date procedures to the Licensing Inspectors satisfaction.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence until 20 August 2019, that being the anniversary date of the licence and three years from the most recent date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.

DECISION (ON THE PAPERS)

This is an application by MK Restaurant Limited for an on-licence in respect of premises situated at 24 Conical Hill Road, Hanmer Springs, known as “MK Restaurant”.

The general nature of the business to be undertaken is that of a Restaurant with the hours authorised for the sale of alcohol between Monday to Sunday from 12.00 noon to 10.00pm.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol, to any person for consumption on the premises and to let people consume alcohol there.

The licence may issue immediately.

Requirements on holders of on-licences

The applicant’s attention is drawn to ss. 51 to 54 of the Act where it is a requirement for all holders of an on-licence to ensure that:

- (1) at all times when the premises are open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.

- (2) at all times when the premises are open for the sale and supply of alcohol, a reasonable range of food is available for sale and consumption on the premises, in portions suitable for a single customer, at reasonable prices and within a reasonable time of being ordered.
- (3) ensure that, at any time customers are lawfully on the premises there is readily available free, comprehensive, and accurate information about the forms of transport from the premises that are available at that time.

The applicant's attention is drawn to ss. 56 and 57 of the Act obliging the holder of an on-licence to display:-

- (1) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol ; AND
- (2) A copy of the licence, together with a statement of all conditions subject to which it is issued, attached to the inside of the premises so as to be easily read by people entering each principal entrance.

The nature of the particular event for which the licence is sought is a Truffle Day Out with the days and hours authorised for the sale of alcohol being Sunday 30 July 2017 from 11.00am to 2.00pm.

The licensed area is supervised and includes the pavilion, the veranda and the paved area in front of the veranda.

This is a ticket only event with tickets only being sold to people 18 years of age and older. Approximately 60 people are expected to attend and will be aged from 25 to 60 years old.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.

The licence may issue immediately.
