The licensee is exempt from the requirements of appointing a manager under subpart 7 of the Act.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an off- site special licence authorising the sale of alcohol, to any person attending this occasion or event (or series of occasions or events) for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licence may issue immediately.
