No changes to the conditions of the licence have been sought by the applicant.

The hours the bar is open for the sale and supply of alcohol are required to be recorded to ensure the hours per week do not exceed 40. The bar is only open when one of three club members are available to open it and they will be advised to record the required information.

The application indicated that the club had two duty managers, however, one is now unwell and will no longer be available. The training of other club members was discussed and this will be further investigated.


The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 17 July 2020, that being the anniversary date of the licence and three years from the most recent date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.
