The applicant is reminded that all staff must have the legal entitlement to work in New Zealand. Failure to ensure this would reflect on the applicant's suitability to hold licences.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.

The licence may issue immediately.

A Fire Evacuation Scheme for the premises was approved under the owner/previous licensee. FENZ have confirmed the necessary trial evacuation was conducted.

The application was duly advertised and no objection or notice of desire to be heard has been received.

The general nature of the business to be undertaken is that of a Tavern with the hours authorised for the sale of alcohol between **Monday to Sunday from 9.00am to 11.30pm**.

Resource Consent 040080 limits the hours of operation to those sought.

However, the consent also states 'That the hours of operation during which the restaurant and bar are open to the public or used for private functions may be extended on **six occasions per year** to be **9am to 1am the following day**, on any given day, provided that any necessary special licences are obtained under the Sale of Liquor Act 1989.' Since the issue of this consent, the Sale of Liquor Act 1989 has been replaced by the Sale and Supply of Alcohol Act 2012.

Silver Fern Hanmer Limited is a new company registered on 18 December 2017. The two company directors and shareholders were born in India, and Ajay Soeny has advised they are both New Zealand citizens who reside in Auckland. The company is part of the VR Group of companies which has an unlicensed restaurant in Queenstown and a number of licensed restaurant and bars in Auckland hotels.

The applicant has entered into a 15 year lease for the premises.

The applicant has held temporary authorities for the on and off-licences for the premises since 1 February 2018 and with an expiry date of 1 May 2018. The Inspector is not aware of any non-compliance issues associated with the management of the premises under the temporary authorities.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol, to any person for consumption on the premises and to let people consume alcohol there.

The licence may issue immediately.

#### Requirements on holders of on-licences

The applicant's attention is drawn to ss. 51 to 54 of the Act where it is a requirement for all holders of an on-licence to ensure that:

- (1) at all times when the premises are open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.
- (2) at all times when the premises are open for the sale and supply of alcohol, a reasonable range of food is available for sale and consumption on the premises, in portions suitable for a single customer, at reasonable prices and within a reasonable time of being ordered.
- (3) ensure that, at any time customers are lawfully on the premises there is readily available free, comprehensive, and accurate information about the forms of transport from the premises that are available at that time.

- (1) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; AND
- (2) A copy of the licence, together with a statement of all conditions subject to which it is issued, attached to the inside of the premises so as to be easily read by people entering each principal entrance.
