The applicant has been provided information on the requirements of the Act and Regulations relating to the information to be included on mail order forms and the website. A draft of the winery's proposed mail order form has been provided and it contains the required two age declarations in the correct parts of the form. The licence information will be added when the licence has been issued.

In addition, the applicant has confirmed the required licence information will be added to the website once the licence is granted and before sales are made through the site. A check of the website will be made, following the issue of the licence, to ensure the correct information is displayed in the required manner.



This is an application by Rotherham Hotel Limited for renewal of an On-Licence in respect of premises situated at 42 George Street, Rotherham, known as "Rotherham Hotel".

The applicant also seeks a variation of licensed area to include 'The Stables' and the adjoining beer garden area.

At the previous renewal in 2015, the licensee advised he would like to license 'The Stables' building and adjoining areas, but had no building consent for the new alterations.

When (in November 2016) the licensee received his Building Certificate of Acceptance, he was advised he could either submit a variation to his existing On licence, or wait until his next renewal was due to add the areas to his licence.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Medical Officer of Health did not oppose the application but commented, '*I am aware that in April 2016, the applicant was warned by the Chief Licensing Inspector as the named duty manager was not on the premises. I am not aware of any other compliance issues since the last renewal.*'

The Police Report received was in opposition to the application due to suitability, stating: '*The Applicant opened the Stables bar in November 2017 despite this area not being licenced. Police became aware of this when checking the premises face book page on 4 May 2018.*'

Police contacted the applicant on 7 May 2018 and asked him about the opening. His response was they did open the Stables bar despite not having a licence.

Constable Genevieve Craddock, Alcohol Harm Reduction Officer, and the Licensing Inspector visited the Rotherham Hotel on 11 May 2018. Subsequent to that visit, Police decided rather than take enforcement action for the breaches of the Act, and a warning letter was issued to the licensee. The opposition to the application was withdrawn.

FENZ did not oppose the application, once the required trial evacuation had taken place.

The District Licensing Inspector have raised no matters in opposition to this application although they have pointed out the non-compliance issues that have occurred since the last renewal.

The District Licensing Committee would like to remind the licensee that he has received formal warning letters from both the Licensing Inspector and the Police, and should not expect to have such leniency again.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence until 21 May 2021, that being the anniversary date of the licence and three years from the most recent date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.

No changes to the conditions of the licence have been sought by the applicant.


The application was duly advertised and no objection or notice of desire to be heard has been received.
