The applicant has named Georgina Duncan as the duty manager for the event. The manager on duty and the security staff will regularly move around the licensed area to observe patrons and be alert to signs of intoxication. The duty manager is responsible for liaison with the stall holders, security staff and enforcement agency staff monitoring the event.

All stall holders selling alcohol will be sent a briefing prior to the event. The manager will hold a briefing for all event staff and stall holders, prior to the commencement of the licensed period, to ensure they are all aware of their roles and responsibilities and the conditions of the licence.

An Alcohol Management Plan was provided with the application which includes information on the management of the event, staffing, display of signage and the use of a 'safe area' in the event of an intoxicated person requiring supervision. The 'Event Duty Manager Checklist' provides additional details relating to how intoxicated person will be managed in

the safe area located at the Ticket Booth, and how their removal from the site will be managed.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.
