The Inspector has discussed with Mike Gaskin, that FENZ are agreeable to licences being renewed once the scheme application has been lodged. There are provision in Section 286 of the Act for FENZ to take further action in the event licensees do not follow the application through to its approval.

(d) must contain the prescribed particulars; and

(e) must be accompanied by a statement by the applicant that-

(i) the owner of the building in which the premises are situated provides and maintains and evacuation scheme.

(f) must be accompanied by the prescribed fee


The application was duly advertised and no objection or notice of desire to be heard has been received.
