DECISION (ON THE PAPERS)

This is an application by Sherwood Estate Wines Limited for renewal of an Off-Licence in respect of premises situated at 113P Church Road, Glenmark, known as "Sherwood Estate Wines Limited".

No changes to the conditions of the licence have been sought by the applicant.

The application was duly advertised and no objection or notice of desire to be heard has been received.

The Sherwood Estate Wines Limited has held its current licence since April 2013. While previously the winery operated a cellar door, no tastings are now held at the winery. Jillian advised that occasionally customers call in to the winery to purchase wine; i.e. an average of approximately one sale per week. The wine sales are made in the meeting room shown on the plan attached to the application. There is an EFTPOS machine located in this area to process the sales.

Most of the wine sales are made by wholesale to restaurants and supermarkets therefore not subject to this off-licence.

Jillian and Dayne Sherwood remain the sole directors and shareholders of the licensee company. Jillian was the only duty manager listed on the application. During the interview Jillian confirmed there are two other duty managers employed at the winery; Petter Evans and Charlotte Cunningham.

Sales of glasses of wine were made to patrons outside of the licensed period at the Waipara/North Canterbury Wine and Food Festival's in 2016 and 2018. These breaches

resulted in a warning letter being sent by the NZ Police Alcohol Harm Reduction Unit on 19 March 2018 to the licensees of Sherwood Estate Wines Limited.

The Police correspondence identified that "Because you sold alcohol outside of the special licence in 2016 and the Wine and Food Celebration Committee's Special Licence in 2018 these were breaches of Section 247 of the Sale and Supply of Alcohol Act"

The District Licensing Committee has noted this apparent lack of compliance by the licensee, and the effect it has on their individual licence applications, as well as recognising the effect that non compliance may have on an over- arching licence.

The District Licensing Committee expect the licensee to contact the Secretary as soon as the website is operational, to ensure the compliance checks can be made.


The District Licensing Committee would also like to make it clear that they expect any future applications from the licensee be closely monitored for compliance to ensure all legislation and conditions are met.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application, but have made comment to compliance issues.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 06 May 2021, that being the anniversary date of the licence and three years from the most recent date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.

This is an application by Koyama Wines Limited for renewal of an Off-Licence in respect of premises situated at 434 Omihi Road, Omihi, known as "Mountford Estate".

No changes to the conditions of the licence have been sought by the applicant.

Koyama Wines Limited was incorporated on December 2013. The company has traded as Mountford, firstly with a temporary authority from June to September 2017, and with an off-licence for the past year.

A site visit was made on 16 October 2018 and the current operation was discussed with the licensee, Takahiro Koyama. He advised the cellar door has operated by appointment only with tastings occurring approximately once per month. The frequency of tastings may increase during the coming summer months.

Takahiro was issued a manager's certificate in November 2017 and is the sole duty manager for the winery. He advised he is present at the tasting events.

The website was checked for compliance with the Act. The site gives information on the wines produced, however it does not advertise the wines or enable the purchase of wine via the internet. Email or telephone contact is required to purchase wine or to make bookings for tastings.


The application was duly advertised and no objection or notice of desire to be heard has been received.

She also is aware that the renewed licence details are to be updated within 2 working days of the receipt of the renewed licence.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

This is an application by Ganpati Enterprises Limited for an on-licence in respect of premises situated at 458 Ashworths Road, Amberley, known as “Pukeko Junction Cafe”.

The general nature of the business to be undertaken is that of a Café/Restaurant with the hours authorised for the sale of alcohol between **Monday to Sunday from 8.00am to 10.00pm.**

Ganpati Enterprises Limited is an existing company registered on 29 August 2012 which previously operated a taxi business. Reena Bist is the sole company director and shareholder.

She has previously held a manager’s certificate and is responsible for some administration roles in regard to the current business, e.g. banking.

Reena’s husband Ankit Bist is the operational manager for the café. Previously they owned and operated a licensed restaurant in Christchurch trading as, ‘It’s Indi’ from 2009 to 2012.

Ganpati Enterprises Limited has purchased the lease of the premises for 16 years.

The café/restaurant will continue to trade under the same name, Pukeko Junction Café. Generally the operation will be very similar to that under the previous licensee, however with some additional food options and extended trading hours to allow for evening meals. Ankit advised that while additional trading hours have been sought for seven days per week, they only intend to open for evening meals approximately two to three times per week. The days sought are to allow for flexibility particularly for group bookings.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol, to any person for consumption on the premises and to let people consume alcohol there.

The licence may issue immediately.

Requirements on holders of on-licences


The applicant's attention is drawn to ss. 51 to 54 of the Act where it is a requirement for all holders of an on-licence to ensure that:

- (1) at all times when the premises are open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.
- (2) at all times when the premises are open for the sale and supply of alcohol, a reasonable range of food is available for sale and consumption on the premises, in portions suitable for a single customer, at reasonable prices and within a reasonable time of being ordered.
- (3) ensure that, at any time customers are lawfully on the premises there is readily available free, comprehensive, and accurate information about the forms of transport from the premises that are available at that time.

The applicant's attention is drawn to ss. 56 and 57 of the Act obliging the holder of an on-licence to display:-

- (1) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol ; AND
- (2) A copy of the licence, together with a statement of all conditions subject to which it is issued, attached to the inside of the premises so as to be easily read by people entering each principal entrance.



Anna-Louise Ashford (Annie) is the proposed manager for this event. She has held a manager's certificate since August 2014 and has over 10 years' experience in the hospitality trade. Annie is the bar manager at the Cheviot Rugby Club. There have been issues associated with Annie's organisation and management of events held under special licences by the rugby club. A second duty manager for the club has been proposed and an application has been received from Julia Dickson. She has previously held a manager's certificate and has experience as a duty manager at the Cheviot Trust Hotel.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.

The licence may issue immediately.
