Sales of alcohol were made to patrons outside of the licensed period at the North Canterbury Wine and Food Festival's in 2016 and 2018. Jillian was the duty manager at the winery's stall at the time of these incidents. These breaches resulted in a warning letter being sent (19 March 2018) to the licensees of Sherwood Estate Wines Limited.

The Inspector considers the applicant has taken on board the issues highlighted from the breaches of the Act, which resulted from the sales of alcohol made outside the licence conditions held by the festival organisers. The Inspector will ensure that Jillian, as a licensee and duty manager, has made adequate provisions to prevent similar situations when seeking future special licences or making sales under the festival over-arching licence.

In their reports, the Police and District Licensing Inspector have raised no matters in opposition to renewal.

Under section 218 of the Act the Committee must not renew a manager's certificate unless the manager holds the prescribed qualification.

As the applicant has successfully completed the Licence Controller Qualification Bridging Test, the committee is satisfied that the criteria as set out in s.224 of the Act has been met.

A renewal notice can be issued and will remain in force until 29 August 2021.
