DECISION (ON THE PAPERS)

This is an application by General Distributors Limited for renewal of an Off-Licence in respect of premises situated at 121 Carters Road, Amberley, known as "Countdown Amberley".

No changes to the conditions of the licence have been sought by the applicant.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their initial reports, the Police, Medical Officer of Health, and District Licensing Inspector all raised matters in opposition to this application.

A report, opposing the renewal application, was received from the Medical Officer of Health on 30 April 2018. The opposition related to the outward facing end of aisle displays of alcohol in the single alcohol area.

An email stating the Medical Officer of Health had withdrawn his opposition to the renewal application was received on 16 October 2018.

A report, opposing the renewal application, was received from Police on 30 April 2018. The opposition related to the outward facing end of aisle displays of alcohol in the single alcohol area.

The Police further reported on 31 July 2018:

'On 30 April 2018 Police opposed the application for renewal due to the exposure under 112(1).

On 27 July 2018 Police went to the premises again to review the single alcohol area.

Based on this visit Police wish to withdraw their opposition to the renewal.'

In May 2015, the Inspector reported positively on the operation and compliance at Countdown Amberley during its first year of operation. However, the Inspector has become aware that there have been failures to adhere to requirements of the Sale and Supply of Alcohol Act 2012 and the company's own internal procedures and policies. These issues of concern relate to staffing, systems and training.

The Inspector has concerns that General Distributors Limited's internal procedures broke down to such an extent at Countdown Amberley, for more than a year, and were not detected until the issues were raised by the Inspector.

Since the applicant has been advised of the opposition and scheduled hearing date, the Licensing Inspector and Mr Paul Radich, Alcohol Responsibility Manager for General Distributors Limited have discussed the issues raised. Following these discussions written responses were received from Mr Radich on 17 August 2018 and 11 September 2018. The emails address a range of issues, and explain existing in-house systems and improvements that have been, or will be implemented.

In acknowledgement of the poor leadership at Countdown Amberley, including the lack of adherence to in-house systems and responsibilities under the Act, the applicant has proposed a reduced renewal period of 18 months to *'show their commitment to getting things right.'*

Concerns about the way the team at Countdown Amberley had been managed were acknowledged and corrective action has been taken, including Mr De La Cruz being replaced as the store manager of Countdown Amberley.

An undertaking has been received from General Distributors Limited that large (A0) price signage will not be hung above the single alcohol area.

There was a request to define the word 'sparingly' when describing the use of floor stacking in the Single Alcohol Area. Response was received from A Arthur-Young on behalf of General Distributors Limited dated 30 October 2018 which clarifies that 'Countdown Amberley' intend to maintain the current level of floor stacking as it is already at a minimum. Floor stacks are not part of the normal store layout or design, but are only used when required. The floor stacking of alcohol should therefore not be increased at any time.

Any other store improvement and procedure mentioned during email correspondence by the applicant and the Inspector shall be monitored for compliance by the Licensing Inspector.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 14 November 2019,

that being eighteen months from the anniversary date of the licence, as proposed by the applicant as a show of commitment to resolving all previous issues.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

Nelson Hospitality Limited was registered on 10 June 2008 and has operated hospitality premises in Dunedin, Christchurch and Nelson. Alan McNabb and Kevin O'Neill are company directors and shareholders. There was initially some confusion over the shareholders however, this was clarified by the applicant's accountants. The named shareholders were representative of Trusts, which are shareholders of Nelson Hospitality Limited or Rubber Ducky Limited, which is a shareholder of the applicant company.

Alan McNabb is the general manager for the company. He holds similar positions as a company director, shareholder and general manager for Hanmer Hospitality Limited, which holds on-licences for Monteiths Brewery Bar, O'Flynn's Bar, Roasted Bean Café and Fire and Ice Café and Restaurant in Hanmer Springs.

The tavern will continue to trade under the same name, the Alpine Village Inn. Alan McNabb has advised no significant changes are anticipated in the nature of the operation of this premises.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.



The application was duly advertised and no objection or notice of desire to be heard has been received.

Nelson Hospitality Limited was registered on 10 June 2008 and has operated hospitality premises in Dunedin, Christchurch and Nelson. Alan McNabb and Kevin O'Neill are company directors and shareholders. There was initially some confusion over the shareholders however this was clarified by the applicant's accountants. The named shareholders were representative of Trusts which are shareholders of Nelson Hospitality Limited or Rubber Ducky Limited, which is a shareholder of the applicant company.

Alan McNabb is the general manager for the company. He holds similar positions as a company director, shareholder and general manager for Hanmer Hospitality Limited, which holds on-licences for Monteiths Brewery Bar, O'Flynn's Bar, Roasted Bean Café and Fire and Ice Café and Restaurant in Hanmer Springs.

The tavern will continue to trade under the same name, the Alpine Village Inn. Alan McNabb has advised no significant changes are anticipated in the nature of the operation of this premises.

- (1) at all times when the premises are open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.
- (2) at all times when the premises are open for the sale and supply of alcohol, a reasonable range of food is available for sale and consumption on the premises, in portions suitable for a single customer, at reasonable prices and within a reasonable time of being ordered.
- (3) ensure that, at any time customers are lawfully on the premises there is readily available free, comprehensive, and accurate information about the forms of transport from the premises that are available at that time.

The applicant's attention is drawn to ss. 56 and 57 of the Act obliging the holder of an on-licence to display:-

- (1) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol ; AND

The nature of the particular event for which the licence is sought is a Garden Party with the days and hours authorised for the sale of alcohol being **Sunday 4 November 2018 from 1.00pm to 6.00pm.**

The licensed area is undesignated, and includes a grassed area directly in front of the house, bordered by flowerbeds. Signage will be placed at exits indicating that alcohol is not to be taken outside these areas.

In their reports, the Police and District Licensing Inspector have raised no matters in opposition to this application, although the Inspector has expressed her concerns regarding poor pre-planning and communication by the applicant. The Medical Officer of Health has not been able to report on this application due to the late filing.

The DLC support the comments of the Licensing Inspector regarding the 'foreseen nature of the event' and reinforces the importance of lodging an application within the timeframes stipulated in the Sale and Supply of Alcohol Act. It has been determined under S.208 that whilst the late application was not "wilful," it must be stressed that in this circumstance poor preparation and organisation between the landowner and the applicant have severely compromised this application.


It must be also noted on the licence that alcohol will not be served if food options are not available for any reason.

The DLC does not intend imposing any further conditions as I am satisfied that this event will be operated in accordance with the Act and that there are no circumstances that would warrant more restrictive conditions over and above the necessity to apply for future applications within the timeframes stipulated in the Act.

The general nature of the business to be undertaken is that of a Hotel with accommodation with the hours authorised for the sale of alcohol between **Monday to Sunday from 10.00am to 2.00am the following day**. The ground floor area (excluding the restaurant) is designated as a supervised area from 10.00pm.

In their reports, the Police and District Licensing Inspector have raised no matters in opposition to this application.

This is the third application for a temporary authority Rogoz Holdings Limited has lodged. The second expired on 18 November 2018.

The third temporary authority is required as there are unresolved building compliance issues. These have resulted in the Building Certificate of Compliance being unable to be issued at this time. The impact of this is that the on-licence application cannot be issued.

It is unusual for third temporary authorities to be required. It is therefore, important for the outstanding building compliance matters be addressed, to enable the Building Certificate of Compliance to be issued during the period of the temporary authority being sought; i.e. a maximum of three months.

We are satisfied as to the matters to which we must have regard as set out in s. 136 of the Act and we grant the applicant a temporary authority for the duration of 3 months, commencing on **26 November 2018**, subject to the current licence **57/ON/456/2017** continuing in force for the duration of the Order.
