### **DECISION (ON THE PAPERS)**

This is an application by Glenmark Rugby Football Club Incorporated for renewal of a Club Licence in respect of premises situated at 9 Reeces Road, Omihi, known as "Glenmark Rugby Football Club Incorporated".

No changes to the conditions of the licence have been sought by the applicant, although they did originally apply for hours outside the Local Alcohol Policy.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application, however FENZ advised 'Glenmark Rugby Club/Omihi Hall have applied and require some more work as it hasn't been approved.'

The scheme has not yet been approved by FENZ. The club's attention is brought to the provisions of Section 286 of the Sale and Supply of Alcohol Act 2012. This section provides for the suspension of licences for non-compliance with public health or fire precaution requirements, i.e. not holding or maintaining an Evacuation Scheme.

The 2015 club-licence renewal application was about to be issued when the Glenmark Rugby Club's premises was destroyed in a fire. The licence has been on-hold since that time until the new Omihi Community Hall was replaced.

In the 2018 renewal application, the club sought to extend the licensed hours until 12 midnight on Monday to Friday. The reasons given were to enable the bar to open after training nights and flexibility in the event of future night games. The installation of lighting

(expected to occur within the next 18 months) will enable the use of the playing grounds for later training and night games.

The Hurunui Local Alcohol Policy restricts club-trading hours to:

Sunday to Friday 8.00am to10.00pm, and 8.00am to 12.00 midnight

The Inspector advised Craig Tomlinson that the additional hours sought exceed the hours permitted by the Hurunui Local Alcohol Policy. He is now aware that should the club seek to open the bar outside of the licensed hours granted then a special licence will be required.

The bar opening hours will be restricted to a maximum of 40 hours per week to meet the Class 3 club criteria. These hours allow for flexibility for training nights, home games and other club events. As per the 2015 renewal application,

The trading hours sought are:

Monday -Friday 4.00pm – 10.00pm Saturday 1.00pm – 12 midnight

Sunday 1.00pm – 10.00pm with a maximum of 40 hours per week.

In addition, a book is required to be kept in the bar area to provide a record of the hours the bar is open and the name of the manager on duty while the bar is open.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence on the existing terms and conditions until 26 August 2021, that being the anniversary date of the licence and three years from the most recent 'expected' date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.
