DECISION (ON THE PAPERS)

This is an application by John Lawrence Burnnand for an off-licence in respect of premises situated at 11 Weka Pass Road, Waikari, known as "Star & Garter Hotel".

The general nature of the business to be undertaken is that of a Hotel with accommodation with the hours authorised for the sale of alcohol between Monday to Sunday from 10.00am to 10.00pm.

The licensed areas are:

- The vinyl floored area immediately in front of the bar (supervised designation)

The collection of takeaway food orders was discussed. These will be collected at the separate counter near the poolroom as it is an undesignated area, which enables unaccompanied minors to collect orders.

The on and off-licences will be held by John Lawrence Burnnand. He has provided evidence that all funds from the sale and supply of alcohol will be banked into an account in his name, trading as Star and Garter Hotel.

John Burnnand and Christine Lewis are the property owners and have previously been the hotel licensees for four years from 2008 until 2012. They will be actively involved in the business, John as a duty manager with Christine's main role being food service. Christine does however, also hold a current managers certificate and so is able to work as a duty manager if necessary.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.


The licence may issue immediately.

Requirements on holders of off-licences

The applicant's attention is drawn to ss. 56 and 57 of the Act obliging the holder of an off-licence to display:-

- (1) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol ; AND
- (2) A copy of the licence, together with a statement of all conditions subject to which it is issued, attached to the inside of the premises so as to be easily read by people entering each principal entrance.
