

# Notice of Decision



Decision No. 57/OFF/477/2019

**DECISION (ON THE PAPERS)**

This is an application by Ripresa Limited for an off-licence in respect of premises situated at 347 MacKenzies Road, Waipara, known as “Bellbird Spring”.

The applicant company was originally incorporated on 5 June 2015, and has subsequently had two name changes. The name was changed to the current company, Ripresa Limited, on 27 April 2017. Thomas Guy Porter (Guy) and Leigh Micelle Anderson are the company directors and shareholders. The business will trade as Bellbird Spring winery.

Guy Porter is the sole duty manager for Bellbird Spring winery. He has held a manager’s certificate since December 2008. He is considered a suitable person to manage the sale and supply of alcohol for the winery.

The general nature of the business to be undertaken is that of a winery making remote sales only with the hours authorised for a remote sale can be made at any time on any day. Restrictions on delivery of alcohol sold by remote sale apply to this licence which includes no deliveries between 11pm on any day and before 6am.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.

The District Licensing Committee reminds the applicant that the new licence information will be required to be updated on the website following the issue of the licence. This should be undertaken within two working days of notification of the issue of the licence.

The licence may issue immediately.

**Requirements on holders of off-licences**

The applicant's attention is drawn to ss. 56 and 57 of the Act obliging the holder of an off-licence to display:-

- (1) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol ; AND
- (2) A copy of the licence, together with a statement of all conditions subject to which it is issued, attached to the inside of the premises so as to be easily read by people entering each principal entrance.
