DECISION (ON THE PAPERS)

This is an application by John Lawrence Burnnand for an on-licence in respect of premises situated at 11 Weka Pass Road, Waikari, known as "Star & Garter Hotel".

The general nature of the business to be undertaken is that of a Hotel with accommodation with the hours authorised for the sale of alcohol between Monday to Sunday from 9.00am to 1.00am the following day.

The licensed areas are:

- The bar and dining/bar area (undesignated until 9.00pm then becomes a supervised area)
- The restaurant, dining room, entrance foyer and poolroom (undesignated)
- The outdoor licensed areas (undesignated)

The application listed one duty manager for the hotel. This is considered inadequate for the hotel with the trading hours and days that are being sought. John and Christine advised that additional duty managers, and other staff, will be employed prior to the premises opening. The names of the duty managers employed will be advised prior to opening.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol, to any person for consumption on the premises and to let people consume alcohol there.

The licence may issue immediately.

Requirements on holders of on-licences

The applicant's attention is drawn to ss. 51 to 54 of the Act where it is a requirement for all holders of an on-licence to ensure that:

- (1) at all times when the premises are open for the sale and supply of alcohol, there is available for sale and consumption on the premises, at reasonable prices, a reasonable range of non-alcoholic drinks.
- (2) at all times when the premises are open for the sale and supply of alcohol, a reasonable range of food is available for sale and consumption on the premises, in portions suitable for a single customer, at reasonable prices and within a reasonable time of being ordered.
- (3) ensure that, at any time customers are lawfully on the premises there is readily available free, comprehensive, and accurate information about the forms of transport from the premises that are available at that time.

The applicant's attention is drawn to ss. 56 and 57 of the Act obliging the holder of an onlicence to display:-

- (1) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol ; <u>AND</u>
- (2) A copy of the licence, together with a statement of all conditions subject to which it is issued, attached to the inside of the premises so as to be easily read by people entering each principal entrance.
