DECISION (ON THE PAPERS)

This is an application by Brew Moon Brewing Company Limited for an on-site special licence in respect of premises situated at 12 Markham Street, Amberley and known as Brew Moon Brewing Company

The nature of the particular event for which the licence is sought is Markham Street Party - Music, Food, Drink, Retail with the days and hours authorised for the sale of alcohol being Saturday 01 February 2020 from 1.00pm to 7.00pm.

The sale of alcohol will cease at 6.30pm, allowing a 30 minute drink up time.

A waiver has been granted by Licensing Committee as the application was late due to the working day closure period

The licensed area will be designated as supervised and will include the interior and outdoor licensed areas of the Brew Moon Brewery, and the outdoor areas in the Brew Moon carpark and a clearly defined area on Markham Street which will be closed to traffic for the street party.

The Brew Moon Brewing Company Limited has held on and off-licences for a tap room in Amberley since December 2015.

The applicant has previously held special licences for the on and off-site sale of their beer at various events including Kaikoura Seafest, the Great Kiwi Beer Feast, the Waipara/North Canterbury Wine and Food Festival and the Amberley A&P Show.

Brew Moon Brewing Company Limited named three experienced duty managers for the event.

Duty Manager

Oscar McCauley has been employed since 2016 at the Brew Moon Brewing Company Limited. His primary role is sales marketing and he undertakes bar work at the Brew Moon Taproom when required. Oscar is usually a duty manager at festivals under special licences. These events have included; Beervana in Wellington, Otago Craft Beer Festival, North Canterbury Wine and Food Festival and the Country Christmas Fete.

Belinda Gould holds a current managers' certificate and has previously managed special licences held by The Brew Moon Brewing Company Limited. Belinda is also a licensee of the company for its taproom in Amberley.

Deborah Brown has holds a manager's certificate and has worked as a casual bar person at The Brew Moon tap room in Amberley, for approximately two years.

The duty manager, will brief all event staff on their roles and responsibilities and the conditions of the licence. This will include that the premises on-licensed areas will be subject to the conditions of the special licence from 1.00pm until 7.00pm. No off-licence sales can be made during the special licensed period.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.

The licence may issue immediately.
