DECISION (ON THE PAPERS)

This is an application by Angus John Galletly for an on-site special licence in respect of premises situated at 15 Heaton Street, Rotherham and known as Amuri Show Grounds

The nature of the particular event for which the licence is sought is Amuri A&P Show with the days and hours authorised for the sale of alcohol being Saturday 07 March 2020 from 12.00 midday to 4.00pm.

A 30-minute 'drink-up' time has been included in the licensed hours sought. **The sale of alcohol at the stalls will cease at 3.30pm.**

This application is sought to provide an over-arching on-site special licence to cover the trade stalls that will be supplying alcohol to their clients. A specified area within the showgrounds has been allocated to these trade stalls.

The licensed area is undesignated and includes the defined "Trade Sites" area marked with white lines.

Angus Galletly was the 2019 Show President and was proactive in ensuring the trade sites at the show operated responsibly and in accordance with the Act. He acknowledges areas for improvement and seeks to implement these at the 2020 show. This is the second time the trade stalls have been covered by an overarching special licence at this show.

He is the duty manager for this licence and he holds a manager's certificate at the Amuri Golf Club and will be assisted by the show Vice-Presidents.

Each stall supplying alcohol will be required to complete an 'Agreement for Amuri A&P Show trade sites to supply liquor'. This sets out the conditions required to be followed by each stall, including the provision of water, non-alcoholic drinks and food.

The stalls selling or supplying alcohol will be checked prior to the commencement of the event and throughout the licensed period.

All stallholders and assistants will be briefed prior to the commencement of the licensed period. This is to ensure they are aware of their roles and responsibilities and the conditions of the licence.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.

The licence may issue immediately.
