**DECISION (ON THE PAPERS)**

This is an application by Hawarden Agricultural & Pastoral Association for an on-site special licence in respect of premises situated at Allandale Road, Hawarden and known as Hawarden Domain

The nature of the particular event for which the licence is sought is Hawarden A&P Show with the days and hours authorised for the sale of alcohol being Saturday 21 March 2020 from 10.30am to 7.30pm. The provision of a **30 minute 'drink-up' time** has been included within the licensed hours.

The licensed areas are:

**Lions Ringside Bar**

- The licenced area will be designated '**supervised**' with trading hours of 11.00am to 7.30pm, the **sale of alcohol will cease at 7.00pm.**
- The boundaries will be defined as the side and back of the marquee, the show ring fence rail and the 1m high wire gates installed as fencing from the show ring fence to the marquee with a single entrance to the bar area.

**Presidents bar**

- The licenced area will be '**undesigned**' with trading hours of 11.00am to 4.00pm, the **sale of alcohol will cease at 3.30pm.**
- The President's bar tent will be located adjacent to the show ring rail, the boundaries defined through the use of rustic gates and bales.
- There will be one entrance/exit to this licensed area.

#### **PGG Wrightson sheep tent**

- The licenced area will be '**undesigned**' with trading hours of 10.30am to 4.00pm, the **sale of alcohol will cease at 3.30pm.**
- Two sides of the PGG tent will form part of the site boundary and the fence to the sheep pens will form another boundary.
- The remaining site boundaries will be defined by lines painted on the ground.

#### **Trade space exhibitors**

- The trade stall licensed areas will be '**undesigned**' with trading hours of 12.00 midday to 4.00pm, the **sale of alcohol will cease at 3.30pm.**
- The site boundaries will be defined by lines painted on the ground.
- The stallholders will be required to keep their patrons within their site boundaries

The Hawarden A&P Association have previously held special licences for the public bar and 'Our Fare' area at the show in 2015, 2016 and 2017. At previous shows, the supply of alcohol had been made at some of the trade stall sites although the licences held for the showgrounds had not covered this.

Christine Mayhew is the proposed manager for the over-arching special licence. She has many years' experience as a duty manager.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.

The licence may issue immediately.
