# **DECISION (ON THE PAPERS)**

This is an application by Dionysus Ventures Limited for an off-site special licence in respect of premises situated at 54P Seddon Street, Cheviot and known as Cheviot Show Grounds

The nature of the particular event for which the licence is sought is Cheviot A&P Show with the days and hours authorised for the sale of alcohol being Saturday 14 March 2020 from 10.00am to 5.00pm. The licensed area is 'supervised' and includes a 10m x 10m gazebo with one closed side inside a defined fenced area.

The stall will be located at the side of the show ring and near the public bar operated by the Cheviot Rugby Club.

The trading hours sought for the licences are:

On-site Special Licence: Saturday 14 March 2020 - 10.30am to 5.00pm

#### The bar will stop serving drinks at 4.30pm to allow for a 30-minute drink-up time.

Off-site Special Licence: Saturday 14 March 2020 - 10.30am to 5.00pm

### The sale of un-opened bottles of wine can be made until 5.00pm

Dionysus Ventures Limited, was previously named Teece Family Vineyards Limited, and trades as Mt Beautiful Wines. The applicant has held special licences for the off-site sale of wine at the Cheviot A&P show from 2015 to 2019 and a bar for on-site sales from 2017 to 2019.

The two duty managers for the stall are:

**Kimberley Eagle** has worked full time as the restaurant and tasting room manager at Mt Beautiful in Cheviot from the end of April 2018. She holds a current manager's certificate issued in October 2018.

**Essentia Feron** has held a manager's certificate since February 2018, and is a duty manager and front-of-house staff member at Mt Beautiful Café and tasting room in Cheviot. In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event ,and

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an off- site special licence authorising the sale of alcohol, to any person attending this occasion or event (or series of occasions or events) for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licence may issue immediately.
