DECISION (ON THE PAPERS)

This is an application by Lions Club of Amuri for an on-site special licence in respect of premises situated at 15 Heaton Street, Rotherham and known as Amuri Showgrounds

The nature of the particular event for which the licence is sought is Amuri A&P Show with the days and hours authorised for the sale of alcohol being Saturday 07 March 2020 from 11.00am to 7.30pm. The licensed areas are:

Public Bar:

- The licensed area will have a '**supervised**' designation for the entire licensed period, 11.00am to 7.30pm.
- This area will be clearly defined by 1.8m high wire mesh fencing, the show ring fence and the walls of the marquee.

Presidents Tent:

- The other end (third) from the bar is the Presidents Tent will have a '**supervised**' designation, alcohol will be available from 11am to 2.00pm.

Extended Licensed Area:

- The additional licensed area will be '**undesigned**' from 5.00pm to 7.30pm.
- The area will be two thirds of the marquee and an outdoor area. The outdoor licensed area will be fenced as above and have a single access point.

The bar will cease serving alcohol at 7.00pm to allow for a 30 minute 'drink-up' time.

The Amuri Lions Club has previously run the public bar at this event. The operation of the bar was monitored during the 2015, 2016, and 2017 shows non-compliance issues were noted.

The applicant has rostered duty managers for the bar. All five proposed managers hold current manager certificates and have experience managing the sale and supply of alcohol, albeit at a range of licensed premises types.

- Trent Allison is the licensee and duty manager at the Red Post Café in Culverden
- Ross Dobby is the duty manager at the Waiiau Bowling Club
- Graeme Gorrie is the duty manager at the Culverden Golf Club
- Alan Lattimore is the licensee and duty manager at the Culverden Hotel and Cafe
- Angus Galletly is the duty manager at the Amuri Golf Club

All staff, (duty managers, bar staff and security) will be briefed prior to the commencement of the licensed period. This is to ensure they are aware of their roles and responsibilities and the conditions of the licence.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending this occasion or event.

The licence may issue immediately.
