**DECISION (ON THE PAPERS)**

This is an application by Conway Flat Community Hall Association Inc for an on-site special licence in respect of premises situated at 209 Conway Flat Road, Conway Flat and known as Conway Flat Community Hall.

In their reports, the Police, and District Licensing Inspector have raised no matters in opposition to this application. The Ministry of Health has not reported due to COVID response commitments.

We are satisfied as to the matters to which we must have regard as set out in s. 142 of the Act and we grant the applicant an on-site special licence authorising the sale and supply of alcohol, to any person attending these events.

The licence may issue immediately.
