**DECISION (ON THE PAPERS)**

This is an application by K and H Limited for a Temporary Authority Order in respect of premises situated at 30E Conical Hill Road, Hanmer Springs, known as “Coriander Leaf”.

The general nature of the business to be undertaken is that of a Restaurant with the hours authorised for the sale of alcohol between **Monday to Sunday from 11.30am to 2.00pm and 5.00pm to 10.00pm.**

K and H Limited has purchased the business from Jeet Holdings No 5 Limited. The applicant has leased the premises from the owner The Francis and Clare Hammond Family Trust.


K and H Limited is an existing company registered on 5 August 2016. The two company directors and shareholders are Karan Sehgal and Harpreet Kaur. The company owned and operated the on-licensed Royal India Restaurant in Geraldine from November 2016 to April 2018.

The Inspector expects applicants to lodge the applications for full licences within the timeframe of the temporary authority and allowing adequate time for processing of the licence application. Further, the Inspector considers the issue of further temporary authorities, should only be granted to accommodate the processing of full licence applications that have been lodged prior to the expiry of the temporary authority.

In their reports, the Police and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 136 of the Act and we grant the applicant a temporary authority for the duration of 3 months, commencing on **22 May 2019**, subject to the current licence **57/ON/384/2017** continuing in force for the duration of the Order.
