DECISION (ON THE PAPERS)

This is an application by The Fresh Food Company Limited for a Temporary Authority Order in respect of premises situated at 94 Carters Road, Amberley, known as "The Fresh Food Company Limited". The store will trade under a different name, which is not currently publically available due to planned marketing promotions.

The general nature of the business to be undertaken is that of a Grocery Store with the hours authorised for the sale of alcohol between Monday to Sunday from 7.00am to 10.00pm.

The Fresh Food Company Limited has purchased the business from Gallaughers Supermarket of Amberley Limited. The applicant has leased the premises from Foodstuffs South Island Limited.

The Fresh Food Company Limited is an existing company registered on 23 December 2015. The two company directors are Stephen Anderson and Timothy Donaldson, and Foodstuffs South Island Limited is the shareholder.

Robin advised that six places are booked, in early July 2019, for Amberley store's staff to attend a two day Licence Controller Qualification Course run by Foodstuffs. The staffing advertisements for the store will be published very soon.

In their reports, the Police and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s. 136 of the Act and we grant the applicant a temporary authority for the duration of 3 months, commencing on 01 July 2019, subject to the current licence 57/OFF/257/2018 continuing in force for the duration of the Order.
