Scope of appellant's evidence


- [4] By **Friday 22 July 2022** the appellant will file and serve a memorandum:
 - (a) confirming the scope of Professor Ogilvie's evidence, including whether he is to give expert evidence on the topics of ecosystem mitigation and environmental compensation as these pertain to lizards and gekos; and
 - (b) confirming witnesses to attend at an expert conference on the topic of noise. It is anticipated the conference will address the effect of noise on amenity values and secondly, disturbance of New Zealand Falcons.

Orders for confidentiality

- [5] Subject to an undertaking to maintain confidentiality, the applicant does not oppose the disclosure of the Lizard Management Plan and secondly, documents pertaining to a Wildlife Permit to counsel or to Professor S Ogilvie. The applicant opposes the disclosure of these documents to Professor A Brower.
- [6] If the appellant seeks disclosure of these documents to Professor Brower an application for orders for confidentiality will need to be made. While the applicant will oppose the application, counsel are to confer on the draft orders and

endeavour to reach agreement on the same.

- [7] Any application seeking orders for confidentiality is to be filed by **Friday 22 July 2022**.
- [8] Leave is reserved for the parties to seek further (or other) directions.
