This is a submission on an application from Hanmer Springs Thermal Pools and Spa (the applicant) for a resource consent to install and operate a gravity-based recreation activity (flyride) on the western face of the Conical Hill Reserve at 54 Lucas Lane, Hanmer Springs.

My Submission is - I oppose the application for the following reasons:

The proposal will have unacceptable adverse effects on the amenity of local residents and users of the conical hill reserve. These effects include but are not limited to, significant effects to noise and privacy and traffic congestion effects on residents and local roads.

The proposal does not achieve the relevant objectives and policies of the Hurunui district plan. The proposal is inconsistent with the provisions of the Reserve Management Plan.

The proposal increases risk of Hazard to residents and property on conical hill with the removal of over 100 trees (as per the submission) which will cause soil instability and higher risk of soil displacement (slips).

The current amenity value of people living in proximity will be severely affected due to the cumulative effect of noise, impact on privacy, vehicles, pedestrians and riders on the fly wire. This will result in more traffic in what are currently very quiet streets designed for the current residential zoning use, not commercial business activities/parking. Properties that currently enjoy peace and quiet due to their location close to the forest and Conical Hill that enjoy the company of Native birds and tranquility in Reserve natural environment will be severely impacted by the proposed increase in visitor numbers and the likely need for the applicant to grow these numbers and add other commercial activities and amenities.

#### Hazard-

From a minimum of 8 trees to be removed to what is expected to be in access of 100 to be removed including desirable native species will cause increased Hazard affects to soil displacement close to residential properties on Conical Hill Reserve. This Hazard is of high Focus and similar to many issues around the world today where weather impact inclusive of reduction of native and monitored planting and replenishment has caused adverse affects to soil displacement. The proposal does not include a risk assessment to cover this.

#### PARKING -

New businesses and activities are required to provide parking. No Parking has been proposed for this Flyride and no consideration to residential zoning requirements for the same areas proposed in the submission. activity, therefore breach Council rules. The intention to use public car parking around residential streets will cause congestion and residents and ratepayers should not have to subsidize a commercial activity by using public property.

#### NOISE -

There is a predicted 80,000 riders in the first year, up to 97,000 in years three. This will adversely affect the amenity value of the walkway and with a capacity of 1400 riders per day, this will significantly add to the adverse effects with the potential to severely affect the current peace and ambiance of Conical Hill for present and future generations, holiday makers and in particular residents including protected species. Once this activity has been established the intention to start Night flights is planned, this will be very disruptive and impact close by residents within 50 meters proximity of the Flyride who currently enjoy peace and tranquility of Conical Hill Reserve and native birds and other protected species.

A generator and lighting which will impact on visitors wishing to experience the Star gazing experience, the lighting will need to be compatible with star gazing equipment.

# WILDLIFE, NATIVE BIRDS AND AT RISK SPECIES -

Two 'at risk-in decline' species the Falcon and Gecko are residing on Conical Hill Reserve.

This natural environment on this Reserve is the perfect place to protect and nurture these precious creatures and native birds and other wildlife that have chosen this location for their homes.

This is something very special to all of us and needs our help to be protected from any commercial activity.

Privacy\_- The proposed 11 meter high towers will impact significantly on properties close to the Flyride which will give invasive views of private living areas of properties close to the Flyride. Given the proposed operating hours this will have sever impact on quality of life for close by residents.
