The poles that would be erected and higher than the 8 metre allowance have no bearing when they are placed in a forest. It is unlikely any noise will unduly disturb Hanmer residents as the location of the proposed site is facing away from the village.

Due to the compact nature of the Hanmer Springs township, most people will walk from the township to the Flyride.

The Hanmer Springs design standards quire possibly need a general overhaul, as some of the criteria for buildings is out of date and has not evolved with the times. Steel poles are fit for purpose, stronger (covering off more recent H and S criteria) and can be easily painted to blend into the natural environment.
