I oppose any commercial activity taking place on Conical Hill that impacts the beauty of that place.

Surely there are other places that could be considered? The application fails to outline why that spot is specifically is preferred.

Conical Hill is an icon for Hanmer Springs. I feel the beauty of the place would be disturbed both visually and from a noise level if resource consent was granted. Currently there are very few man-made structures on Conical Hill and those that are there, are non-intrusive and support admiration of the natural beauty such as the look out.
